- 1.Every group or Sig who uses the Barnstormers Club Flying Field shall, compete the application paperwork and submit it, to the Chairman or Secretary of Barnstormers Club at least 2 months prior to the proposed event is held.
- 2. If permission, in principle is given by the Barnstormer Committee,
- (a,)Submit Exemption Permit, authorised by SAMAA if existing CAA or SAMAA Regulations, especially for height are to be exceeded (b.)Submit

written confirmation that the event will be covered by the required third party Insurance cover. a obtain any exemption required from SAMAA, in full and submit the application to the chairman or secretary at least one months prior to the Event. Submit the names of the RESPONSIBLE Person, the Flight line Controller, the Safety officer for the day

- 3. Without written permission from the Barnstormers Committee, no event will take place.
- 4.It must be noted that All pilots who fly at the Barnstormers Model flying field, shall
- (a.) Be paid up SAMAA Members, with as a SAMAA silver proficiency qualification
- (b.) comply with SAMAA Rules, Regulations, Mops and Safety Rules, and any CAA or ICASA Requirement applicable to model aircraft. (c.)SIGS will
- comply with the CIAM Competition Regulations as set out in CiAM Documentation ABR 4 applicable to their class.
- (d)ALL flying will comply with the CAA requirement of all flying to be within "line of Sight", Maximum height usage of 400 ft AGL, and all radio equipment used to comply with ICASA type approved equipment.
- (e.) Submit a sined copy of the INDEMNITY to the Barnstormers Chairman or Secretary at least one week prior to the date of the Event.
- 5. Barnstormers Committee will confirm, by issuing a Letter to the potential user confirming the Agreement and terms and conditions applicable to the Agreement.
- 6. The Responsible person must understand that during the period of the Event, he is fully and solely responsible for all flying taking place at the Barnstormers Field, and as such is the Responsible person in terms of this Agreement
- 7.It is understood that the user will leave field and facilities in the same state as he received it and that any cost incurred by the user for advertising ,security,or running of his event will be to his account.
- 8. Costs for damage to club equipment, buildings, toilets or facilities will be paid for by the user.
- 9..Ifthe user allows SAMAA Solo qualified pilots to fly, when spectators are present, suitably qualified instructors will be attendance.
